

# Winter Bonus Spend & Get

## Terms and conditions

1. Information on how to claim the bonus Digital Visa Gift Cards form part of these conditions.
2. The promotion runs from the **2<sup>nd</sup> June 2022 – 12<sup>th</sup> June 2022**
3. Offer is open to individuals who purchase eligible products within specified categories by participating brands.

**Eligible categories:** Ovens, Cooktops, Ranges, Dishwashers, BBQs, Wine Cabinets, Fridges, Freezers, Sinkware

**Eligible brands:** Smeg, Fisher & Paykel, Electrolux, Vintec, Schweigen, iLVE, BeefEater, Westinghouse, Beko, Zip, LG

4. Individuals who purchase these products are eligible to receive a bonus Digital Visa Gift Card through application and proof of purchase, and deposit paid.

**Deposit paid purchases** - A 30% deposit must be paid within the promotional period and full payment must be paid to be eligible for gift card. Full payment must be paid by the 12<sup>th</sup> September 2022 to be eligible for gift card.

**Invoiced and fully paid purchases** - A fully paid invoice must be supplied at point of redemption.
