

# Electrolux Kitchen Cashback

## Terms and conditions

1. Information on how to claim the bonus Visa Gift Cards form part of these conditions.
2. The promotion runs from the **17<sup>th</sup> April – 30<sup>th</sup> April 2023**.
3. Offer is open to individuals who purchase eligible products within specified categories by participating brands.

**Eligible categories:** Ovens, Freestanding Cookers, Rangehoods, Cooktops, Dishwashers, Fridges, and Wine Cabinets

**Eligible brands:** Electrolux

4. Individuals who purchase these products are eligible to receive a bonus Visa Gift Card through application and proof of purchase, and deposit paid.  
**Deposit paid purchases** - A 30% deposit must be paid within the promotional period and full payment must be paid to be eligible for gift card. Full payment must be paid by 30<sup>th</sup> June 2023 to be eligible for gift card.
